MINUTES

1. Chairman's opening address, new context for PNGC

(DD)

- a. Acknowledgement of many years hard slog to get where we are; Update on overall direction; risks; sensitivities.
- b. Currency & adequate funding maintained through sharing with AGA. Now at MW with a good base and opportunity.
- 2. Committee Introductions and Apologies

(DD)

- a. Apologies were received from Chris McCulloch and Guy Jarvis.
- 3. Chairman's MW site progress; overview of club status and direction

(DD)

- a. PNGC operation now defined and agreed with Board of Trustees. 3 sites MW, NETH, SUL. Any operations from elsewhere need to be properly organised and administrated we operate at MW by agreement with AAC; new Commandant in post.
- b. Good support at SUL.
- c. MOU with UPA needs to be renegotiated; to be harmonised with AGA/RNGSA.
- d. Changes afoot in gliding. Dec 8: training structure under BGA as the ATO. (See 5e below)
- e. Can expect to be audited by RN; BGA and the Army.
- f. Ops at MW currently separated by time (booking); hope to move towards better integration.
- g. PNGC 'owned' by Board of Trustees & Directors but is a Naval Sports Association new President Cdre Griffin (VL). Can expect audit from RN idc.
- h. Never forget club, fun, but AVIATION.
- i. Site:

- Grants totalling £25k from RNRMC, FAABT, Nuffield, and SL have been gratefully acknowledged; but come with Ts&Cs, including promotion of RNRMC and the wider RN community that it serves.
- ii. Plans for new temp hangar; needs surety of tenancy Licence now signed with DIO; next step is a Lease, enabling us to take on various liabilities with consequent savings on contractors and by self-help.
- iii. CANNOT sign lease without a financial agreement; typically 15k for first year but abatement yet to be agreed.
- iv. RE assistance hoped for (as originally planned) to erect hangar; survey required before/during/after.

4. Club management proposed structure and TORs

(JS)

a. Proposal per Powerpoint: Structure & TORs

ACTION: ALL to confirm to JS

b. Safety Officer needs to report to Chairman not CFI; independent oversight of everything (flying/ground/people etc); permission for whole operation at MW depends on establishment of the Safe Operating Environment (SOE).

5. Committee Members

a. Safety matters - Flying

(TW)

- i. Safety must be the bedrock of everything we do at MW. Importance of steady and structured approach to re-starting was emphasised; pilots must keep to the briefed sorties.
- ii. A meeting is scheduled for 29/3 with MW AFM, AFA & HAF to agree w/e coordination; hoping to progress from mutually exclusive operations.
- iii. AN has accepted nomination as DCFI. He has been emailing out safety/refresher training to members.

b. Safety Matters – H&S; Ground; Child Protection Officer (CPO)

(JS)

- i. 'Estate' vigilance (eg ISO container doors); mindful of changes;
- ii. Looking for a Safety Officer
- iii. DD: everyone's duty but has to boil down to specifics. A single mishap would do considerable damage and set PNGC back a long way; plus a number of people were displaced to allow us in, so we can expect to be monitored carefully from many angles.
- iv. Hope to re-introduce young people; esp service families; One vulnerability is lack of CPO.

ACTION: **TW** to ask Yvonne/SI

c. Membership.

(JC)

- i. 121 members of which 76 mil; But approx. 20 from previous courses did not attend in 2020 so numbers are realistically 98 (54 mil).
- ii. Glidex/Membership systems are quite integrated now. Will try to get more people trained to operate Glidex on Saturdays.
- iii. Issues with charging for tug flying (not towing) to be set up through Glidex £2/min
- iv. M/G flying not being recorded through Glidex
- v. Debtors will be chased. Plus new members need to start payments

- vi. DD: Annual renewal was always an opportunity to ask what people can do for the club ACTION: **JC** to ask members
- vii. Mem categories & status NB. look at 'Entitled Personnel' plus how best to count people ACTION: **BW/JC/JS** to convene discussion
- viii. Need a coherent policy for Instructor/Tug pilot membership fees. ACTION: TW
- ix. Medicals inc. Self-declared need to be recorded on Glidex. NB. First Solo requires AME. ACTION: JC
- x. First year membership discount will apply for 2021 renewals ACTION: JC

d. Estates (JS)

- i. Sending a new request for RE to install hangar but will be dependent on both COVID and their availability. Having to pay for commercial option is still a possibility.
- ii. Vehicles need to go under cover
- iii. Holmlea Cottage will be a while. Water is an issue. Will be aggravated if DFRS stop w/e ops from 5 Apr.
- iv. Fuel: plan on whether to bring Bowser from Camp through Crash gate 2 or through the camp/airfield gate needs to be resolved.

 ACTION: TW
- v. There is a wish to acquire Portakabin clubhouse/briefing room, but funding cannot be ascertained until after other estates issues are resolved.
- vi. DD: daily attendance of all personnel on site at MW still needs to be recorded.

ACTION: JS / AII

e. <u>Air Ops, Training</u> (TW)

- OPS: Instructor currency flying achieved; Solo flying restart 2 April subj to CFI; 17 Apr dual flying restarts.
- ii. Declared Training Organisation:

(AN)

- This is a new construct delegated by CAA to BGA from 8 Dec. It represents major changes for all gliding training.
- 2. For pilots: from 8 Dec, any solo pilot needs an SPL or will revert to Student status; plus new medical regime starts.
- For PNGC: Roles HoT (CFI); CAA rep (Chairman); club will require more structured approach to all training: briefing rooms, radio, ATC, records, regulation around instructors; new BGA syllabus & training card; club training policies/syllabi etc;
- Annual report to CAA; BGA audit every 2 years; important to get good result first time.
- 5. Safety portfolio New Hazard Log.
- iii. Tug: at Netheravon with Grob. Only solo flying until 12 April.

(LA)

iv. Fuel: JS stressed importance of accurate documentation

ACTION: LA for All Tug and MG pilots.

f. Air Engineering, maintenance, aircraft fleet status

(DH)

- i. Good availability of a/c. Target 17 April (N3 and N7 at MW; LPV at SUL). N3 has an airbrake issue (in the wing?)
 ii. 2 new parachutes on order (9 seats in club.)
- iii. Aim to get some ready-use spares up to MW.
- iv. HERON Astir may arrive idc.

g. Ground Equipment, maintenance and status

(SG)

- i. HERON winch now at MW. It uses Dyneema cable.
 - 1. Dyneema has smaller parachute <u>not</u> interchangeable
 - 2. You CANNOT drive over cable. ACTION: **SG** for All Members
 - 3. Must relax cable on winch at the end of the day run out, wind in with no load except small black tyre.

 ACTION: SG for all Winch Drivers
- ii. Minibus is offline with clutch problem.
- iii. 1x tractor u/s head gasket? Needs to go to SUL for repair.
- iv. Jeep rodent damage repaired.
- v. Bus frost damage repaired.
- vi. Log cabin new roof fitted.
- vii. HERON Bowser at MW.

h. Admin, records (SI)

- Website docs reviewed & updated; Log Cabin copies are NOT yet the updated versions..
- ii. Any website errors should be put to SI.

- i. 48k in bank; outstanding: hangar, installation, site rent.
- j. General Management matters

(JS)

- i. Currency (air/ground) is low first month = lots of checks BUT we must also look ahead; we need to re-start Navy courses (June) and Trial lessons from June/July.
- k. Communications / positioning / Charter / branding

(DD)

- i. T's & C's attached to RNSL Grant requires a 'Commissioning Event', with VIPs etc.
- ii. Shortage of time precluded further discussion.

(JS)

a. RNGSA course dates to be entered on calendar on website

- b. Foundation courses admin in place from last year;
- c. Will need someone to take over as Site Manager from July.
